ATHENS CITY COUNCIL MINUTES OF MEETING

March 20, 2018

The Athens City Council met in regular session on Tuesday, March 20, 2018, at 6:00 p.m. with Mayor Burris presiding. At the request of Council Member Raper, the invocation was given by Pastor Gale Miller; and upon roll call, the following members were present:

- 1 - MINUTES

The Minutes of the regularly scheduled meeting of February 20, 2018 were submitted and approved by unanimous consent.

- 2 -COMMUNICATIONS

PRESENTATION OF VIVID AWARD - MIKE AND MERNA JAQUISH

Council Member Perkinson presented the Very Important Volunteer Individuals (VIVID) Award for the month of March 2018 to Mike and Merna Jaquish for their volunteer work at E.G. Fisher Public Library. Mr. Jaquish thanked the City for giving them the award but he did not feel they were doing anything special because they love the library.

Mayor Burris read the following before opening up the Petitions and Request portion of the agenda. "I've heard several rumors going around about our city schools recently; I would like to address those rumors. Let me be very clear, nothing has changed. The City Council and our School Board have been open about our process. Over the past few years the School Board has hired consultants to evaluate the condition of our school buildings and to look at options to overcome identified deficiencies. The City Council fully understands the importance of all city services to our citizens and visitors - police, fire, parks, utilities, community development, public works, and our schools. The citizens have identified the services that they want our city to provide, and that they want to pay for - and that's exactly what we do. This Council has a duty to fully understand all the needs of our city and so, when it comes to our schools, we have hired one of the best educational consulting firms in the nation to help us and the citizens fully explore our current situation and to identify the best solutions for the future. This Council pays very close attention to the needs of our citizens, every single one of them. We are still months away from a final report being delivered from our consultants, which will include community engagement - which will be difficult to address if these rumors, lies, and embellishments continue. The source of these rumors isn't in this room, but we know where it's coming from, and we ask that it stops for the good of our City and our people."

Mayor Burris opened the meeting for petitions and requests from the audience. Bob Sevigny, 302 Athenian Street, asked the Council when they consider the issue of the splashpad on the agenda to consider funding the whole project. Linda Long, 302 Kilgore Street, stated the City needs to finish what it starts. At Cook Park the men were pulled off the job to work somewhere else. They need to properly finish the job at that park before they move to another park. She felt another coat of paint was needed on the walls and floors of the bathrooms and on the

pavilion. The lighting improvements also needed to be finished. The City needs to then focus on the other parks not just Athens Regional Park. Jill Swafford, Principal of Ingleside School, stated she had always heard good things about Athens City Schools which is why she chose to work for them. People drive miles in order for their children to attend its schools. The schools are the hub of the community and their commitment is to the kids and excellence. She thanked the City Council, Athens Police and Fire Departments for all they do for the schools. Tom Hansford, 403 Lynwood Drive, stated he was an advocate for the Athens City Schools System. His family chose to move to Athens because of Athens City Schools system and its reputation. He understands money is a big factor and felt there were a lot of people willing to pay more to keep the City schools, they just had to rally those people. He could not image what the City would be like without the Athens City School system.
