# ATHENS CITY COUNCIL MINUTES OF MEETING

July 21, 2020

The Athens City Council met in regular session on Tuesday, July 21, 2020, at 6:00 p.m. with Mayor Burris presiding. This meeting was held pursuant to Governor Bill Lee's Executive Order # 16, allowing the virtual attendance of council members, and CDC/White House guidelines limiting the number of the group present. The City of Athens upholds its citizens right to witness their legislative body in action and provided this meeting by livestream and the ability to physically attend. The invocation was given by Mayor Burris; and upon roll call, the following members were present:

The following decisions were made and ordered made a part of the records of the Athens City Council.

Council Member Coker asked for a point of personal privilege. He announced that he had moved his permanent residence outside the city limits and was resigning his seat on the Athens City Council. He and his wife sold their Athens residence last year with the intention of finding a new home in the city. Unfortunately, they were unable to find another home in Athens that met their needs and ended up purchasing a home outside of the city. Council Member Coker stated it was his intent to maintain a residence in Athens for the duration of his Council term at an apartment he owns on North Jackson Street above his business, Coker Millwrights. When he eventually discussed his situation with City Attorney Trew and the McMinn County Elections Commission, he was informed by the Election Commission that because of the zoning laws the residence could not be used as his primary residence. Mayor Burris and members of the City Council expressed their thanks to Council Member Coker for his service and expressed their best wishes. Council Member Coker then asked to be excused. Mayor Burris stated that according to the City Charter, when any vacancy in the council occurs, the vacancy shall be filled by appointment of the council members. He asked that the Council discuss appointing a replacement to serve the remainder of Coker's unexpired term at the Council's next study session, scheduled for August 10, 2020.
