- 15 -REQUESTS FROM CITIZENS

Ray Priest, 2423 Colonial Drive, stated he had heard some disturbing news that the City was being sued by Glenn Whiting and City Attorney Trew and City Manager Sumner were also being personally sued in the lawsuit and represented by Public Entity Partners (PEP) attorneys. Mr. Priest did not feel PEP should be representing the two individuals personally and that they should be doing that themselves. Mayor Burris stated the Council could not discuss this lawsuit. City Manager Sumner stated that either Mr. Priest could contact the attorney from Public Entity Partners directly or he could contact the attorney and have him contact Mr. Priest with the answer to his question. Judith Bosowski, 218 Kenneth Street, stated she was representing the residents on Kenneth Street. She stated the problem they were having was with a tract of land approximately 12.5 acres. The owners of that property have decided to log the property, which is their right. The problem is they are using Kenneth Street to bring their logging trucks in and out of the property along the full length of the street to Haines Road. In the thirteen years she has lived on Kenneth Street, there has been no maintenance on Kenneth Street. Children play in the street and people walk in the street because there are no sidewalks. They felt an access road could be opened on the property onto Million instead of Kenneth. The residents wanted to know if the City could do something to encourage the property owners to open an access road on Million Street to alleviate this situation.
