MINUTES OF MEETING, ATHENS CITY COUNCIL, NOVEMBER 15, 2016

The Athens City Council met in regular session on Tuesday, November 15, 2016, at 6:00 p.m. with Mayor Davis presiding. The invocation was given by Mayor Davis; and upon roll call, the following members were present:

The following decisions were made and ordered made a part of the records of the Athens City Council.

- 1 -MINUTES

The Minutes of the regularly scheduled meeting of October 18, 2016 was submitted and approved by unanimous consent.

- 2 -COMMUNICATIONS

TENNESSEE ASA COMPLEX OF THE YEAR

Mayor Davis announced that the Tennessee Amateur Softball Association, Inc. had informed Austin Fesmire, Director of Parks and Recreation, that the Athens Regional Park Complex had been nominated and selected as the Tennessee ASA Complex of the Year.

PRESENTATION OF CERTIFICATE OF APPRECIATION

Mayor Davis presented a Certificate of Appreciation from the Tennessee Municipal League Risk Management Pool to the City of Athens for thirty five years of membership.

DISTINGUISHED SERVICE AWARD

Mayor Davis acknowledged the recent resignation of Public Works Shawn Lindsey, effective December 2, 2016. In honor of his years of service (since January 31, 2005), the City Council recognized his tremendous contributions to this community through the presentation of a *Distinguished Service Award*.

PETITIONS AND REQUESTS

AUDIENCE

Mayor Davis opened the meeting for petitions and requests from the audience. Laura LeNoir, 922 Woodward Avenue, stated she was with the Cemeteries of Athens Preservation Association (COAPA). On behalf of the members of the Association, thanked Mayor Davis for creating the organization. In 2009, Mayor Davis met with a group of concerned citizens who were worried about the condition of the cemeteries in the city of Athens. Mayor Davis set about creating the association. The group learned to properly reset and repair grave stones as well as researched and addressed endangered stones. To date, the group has addressed approximately 250 stones. They are preserving history one stone at a time thanks to Mayor Davis. Larry Eaton, 279 Sweetfield Valley Road, stated he believed the city has seen a change this election and felt there were issues that needed to be addressed. Mr. Eaton explained that the FOIA requests he had been submitting had been to seek the truth of government expenses. He urged the new city council to have an open and transparent government. Mr. Eaton commented that since Mayor Davis had been in office a lot of great things had been accomplished. Patti Greek, 102 Forrest Avenue, President of the Downtown Business Association and Chairman of the Athens Main Street Board, stated in February of 2015, Mayor Davis gathered several members of the

Downtown Business Association to look at the Main Street as a program and to see if they could bring it to Athens. With her guidance, help and encouragement, they brought this program to the City Council and asked for their support. Normally the program takes 12 to 18 months to prepare the application and another six months for the State to review and approve it. They were able to complete the entire process in seven months. Ms. Greek stated she felt without the Mayor's guidance and support they could not have accomplished what they did to become a Main Street community. On behalf of the Downtown Business Association and Main Street, she thanked Mayor Davis for all of her time, energy and support. Laura Sullivan, 19 Shawnee Trail, commented on her observations since she started to attend the meetings of the City Council. She stated council members sign an oath that states they shall refrain from abusive conduct, personal charges or verbal attacks upon the character or motives of other members of the City Council, boards, committees, staff or the public. Ms. Sullivan felt that Mayor Davis and Vice Mayor Perkinson had broken this oath when they got up and left the October meeting while Council Member Pelley was speaking. Ms. Sullivan stated that although she had a problem with the Mayor's behavior she wished Mayor Davis well. Stewart Smith, 1801 Cherokee Street, Executive Director of Tennessee College of Applied Technology at Athens, expressed his appreciation to Mayor Davis for her efforts in local workforce development and industrial recruitment. Mr. Smith stated Mayor Davis had been integral in developing initiatives and programs to expand McMinn County's industrial base and skilled labor pool. Jordan Curtis, 502 Lynn Avenue, congratulated the winners of the election. He stated there was a lot of energy in this election and urged everyone to use that energy in a positive means and move forward. There is a lot of great work that they can do and asked everyone to come together and work on it to make Athens the place that they know it is and aspire to be as great as it possibly can. Whitney Kimball Coe, 1111 Guille Street, expressed her appreciation to Shawn Lindsey and Mayor Davis for their service to the community. Ms. Coe commented that she felt that both Jordan Curtis and she were voices of the next generation of leadership that could come and serve the City at some point in the near future. They want to see more of the access and connection for their families, young people and professionals. It was her hope that the Council going forward would take a broad look at the future in 20 or 30 years which should include a more diverse economy, small businesses, young professionals and how the city can make it more accessible for them to start their businesses. A lot of that will have to do with broadband. The schools are also important to the community as they are the foundation of all they do. Public education is the bedrock that they build the city on. Several members of the City Council thanked Mayor Davis for service to the community and hoped she would stay involved in workforce development and the Main Street program.

FINANCE DEPARTMENT REPORT

Finance Director Michael Keith presented the Finance Department Report for the month of October 2016. The report was accepted as presented.

Mayor Davis asked Mr. Keith to explain the sales tax collection process. Mr. Keith stated sales tax is collected by the businesses and forwarded to the State by the 20th of the following month. The State distributes the City's share no later than the 20th of the following month. The State keeps 7% and 2% goes to the City. Athens City Schools receives from the City approximately half of the 2%. In the end, the City receives 1% of the 9% collected two months after the revenue is collected.

Michael (Mike) Tallent as interim city manager effective January 1, 2017 with a monthly salary of \$8,000 and approval to work with City Manager Moore for one week.
