The Athens City Council met in called session on November 28, 2016, at 11:00 a.m. with Mayor Davis presiding. The invocation was given by Vice Mayor Perkinson; and upon roll call, the following members were present:

#### - 1 -MINUTES

#### - 3 -SWEARING IN OF NEWLY ELECTED COUNCIL MEMBERS

The swearing in of the newly-elected council members (Burris and Coker) was conducted by City Attorney Chris Trew. Upon seating of the new council, followed by roll call, the following members were in attendance:

# - 4 - REORGANIZATION OF COUNCIL

The method of selecting the mayor is determined by the Charter of the City of Athens (Article V; Sections 1 & 11), whereby the councilmen at the first regular meeting after each biennial election shall elect from one of their number a mayor and vice mayor for a term of two years.

#### **ELECTION OF MAYOR**

To begin the reorganization of the Council, City Attorney Trew announced he would accept nominations for the election of mayor.

Council Member Perkinson moved to nominate Council Member Burris to serve a two-year term as Mayor, seconded by Council Member Raper. Council Member Perkinson stated he felt Council Member Burris would serve the city of Athens well as Mayor. Council Member Coker stated that since Council Member Burris received the largest percentage of votes, he should be the nominee for Mayor. He felt Council Member Burris would do a fantastic job and the citizens had chosen well. He looked forward to the opportunity to serve the citizens under Council Member Burris' leadership. The motion to elect Council Member Burris as Mayor passed by the following roll call vote:

AYES: Burris, Coker, Pelley, Perkinson, Raper

NAYS: None ABSTAIN: Burris

### **ELECTION OF VICE MAYOR**

Mayor Burris announced he would accept nominations for the election of vice mayor.

Council Member Raper moved to nominate Council Member Perkinson to serve a two-year term as Vice Mayor. The motion died for lack of a second.

Council Member Coker moved to nominate Council Member Pelley to serve a twoyear term as Vice Mayor, seconded by Mayor Burris. He stated he had contacted the McMinn County Elections Commission and found that Council Member Pelley had led the voting in 2014 when he, Council Member Perkinson and Council Member Raper were on the ballot. This was the primary reason he felt Council Member Pelley should be nominated for Vice Mayor. Council Member Perkinson stated he could not vote for Council Member Pelley. He wanted to strive for unity on the Council and felt he had worked to that effect. He expected and wanted everybody else to also, but, for that reason, he could not vote for Council Member Pelley for Vice Mayor. Mayor Burris stated that every time Council Member Pelley ran for election he was the top vote getter. He promised that the one thing he would work hard for was to have everyone respect each other. They may not always agree with each other but they will respect each other and the citizens of Athens. Council Member Raper asked Council Member Pelley for better communication with his fellow council members. Council Member Coker stated they were going to be civil to one another and they were going to listen to the people. He commented that he plans to push for the elimination of the three-minute time limit on individual public comments during Council meetings. Upon conclusion of the discussion, the motion to elect Council Member Pelley as Vice Mayor passed by the following roll call vote:

AYES: Burris, Coker, Pelley NAYS: Perkinson, Raper

#### APPOINTMENT OF COUNCIL REPRESENTATIVES

Mayor Burris deferred appointment of council representatives until the December 20, 2016 meeting. He wanted to have an opportunity to discuss the appointments with the Council at their December 12, 2016 Work Session.
