- 1 -<u>MINUTES</u>

The Minutes of the Called Meeting of November 28, 2016 were submitted and approved by unanimous consent.

- 2 -COMMUNICATIONS

PRESENTATION OF VIVID AWARD

Vice Mayor Pelley presented the Very Important Volunteer Individual Award for December 2016 to Charles Allen Bailey for his outstanding community service.

- 3 -PETITIONS AND REQUESTS

<u>AUDIENCE</u>

Mayor Burris opened the meeting for petitions and requests from the audience. Steven S. Sherlin, 1410 Crestway Drive, stated in July 2015 he created the "City of Athens, Tennessee" Facebook group to give the citizens of Athens a platform to voice their opinions so they may be heard by the Athens City Council and the City leaders. He asked Eric Morrow to be the administrator of the site and to help monitor it. Since that time, Mr. Morrow has instituted live streaming that has been overwhelming received by the public. This is a political group but is open to the public. Their goal is to bring issues to the attention of the citizens of Athens and City government. Mr. Sherlin urged the Council to use this group to stay informed of the concerns of those that elected them. ATHENS CITY SCHOOLS QUARTERLY REPORT

Dr. Melanie Miller, Superintendent of Athens City Schools, presented the City Council with her quarterly update. She covered topics on Enrollment and Attendance, TN Report Card, Facility Planning, Activities, Special Recognitions/Activities, Family/Community Connection and Let's Read 20. Dr. Miller noted the TN Report Card had been released and this year Athens City Schools had received a five (5) in all of their TVAAS categories, which is the highest score they could receive. She also noted that the "Economically Disadvantaged Student Percent" on the report was 41.6%. For the last few years, they have reported that this percentage had been moving up and last year it was reported at almost 80%. State and federal laws have changed on how they designate economically disadvantaged students. In the past, it would be based on students that were eligible for free or reduced lunches. Now it is based on those that are directly certified as receiving government assistance. The economics have not changed. Dr. Miller invited the City Manager and City Council to Mr. Winter's technology classroom demonstration on Wednesday, January 25, 2017 at 11:40 a.m. at the Middle School prior to the Athens City School Board's work session.

CONSIDERATION OF PROPOSED ORDINANCE TO UPDATE VARIOUS BUILDING AND FIRE CODES

ORDINANCE NO. 1058 – FIRST READING

AN ORDINANCE TO AMEND THE ATHENS MUNICIPAL CODE, TITLE 7 ENTITLED "FIRE PROTECTION AND FIREWORKS" AND TITLE 12 ENTITLED 'BUILDING, UTILITY, ETC. CODES' TO ADOPT THE 2015 EDITION OF THE INTERNATIONAL RESIDENTIAL, BUILDING, PLUMBING, MECHANICAL, GAS AND FIRE CODES; 2014 EDITION OF THE NATIONAL ELECTRICAL CODE; AND THE 2010 ADA STANDARDS FOR ACCESSIBLE DESIGN

MANAGER'S REPORT

City Manager Moore presented the Manager's Report. He reviewed the progress of current city projects/meetings scheduled during the months of December/January. They have picked up 1,700,000 plus pounds of limbs and brush since November 30th. City Manager Moore stated he did not want anyone to forget that the Police, Fire and Public Works did a great job but the support staff was also asked to do all sorts of things to assist and they did it very well. Everyone worked together without bickering or complaining to get the job done. The City Council had tentatively set the Council Planning Retreat for February 10 and 11, 2017 and everyone was going to check their calendars to see if they had any scheduling conflicts. Council Member Raper stated the Daddy Daughter Dance was scheduled for that same weekend and she has worked that event for 26 years. City Manager Moore asked the City Council to review their calendars and let him know which dates will work for them. The report was accepted as presented.

City Manager Moore announced Captain Rob Davis would serve as Interim Police Chief beginning January 1, 2017 until a new police chief is hired by the new city manager.
